* Transfer Certificate should be issued only under the signature of the regular Principal / Vice Principal and it should be counter-signed by an officer not below the rank of District Inspector of Schools/Deputy Director of Education/Education Officer of the Education Deptt. of the State/Union Territory concerned. In case of a student migrating from one CBSE affiliated school to another CBSE affiliated school the Transfer Certificate of a previous school of such a student may be countersigned by the Regional Officer/Asstt. Secretary / Section Officer of the Board or the Asstt.
